2013 RESOLUTION AWARD OF CONTRACT

AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR A PROFESSIONAL SURVEILLANCE SYSTEM

WHEREAS, the Township of Bloomfield needs the services of ProActive Technology Solutions; and

WHEREAS, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Chief of Police has determined that the value of these services will exceed \$17,500; and


WHEREAS, this contract will end on December 31, 2013; and

WHEREAS, ProActive Technology Solutions, 289 Hwy 33, Manalapan, New Jersey 07726-8364 has submitted the attached proposal indicating they will provide the services at a cost not to exceed \$25,000.00; and

WHEREAS, ProActive Technology Solutions has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit ProActive Technology Solutions from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service.

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification, the Chief of Police Determination of Value, the proposal of ProActive Technology Solutions and the contract itself be placed on file with this resolution; and

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days' notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and


BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
