**2013 RESOLUTION TAX APPEALS**

**RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2009 TAX APPEAL ENTITLED BROOKSIDE MANOR INC.
