WHEREAS, the Director of Information Technology (DoIT) recommends that the Township of Bloomfield contract with Comcast Business Class Services for such services; and

WHEREAS, Comcast Business Class Services has indicated they shall provide the delivery and installation of Internet Data Services For Firehouse 2 Located at 90 Watsessing Ave, Firehouse 3 Located at 124 E. Passaic Ave., and Firehouse 4 Located at 1233 Broad St.; and

WHEREAS, the Director of Information Technology (DoIT) has determined that the value of the services will not exceed \$17,500; and

WHEREAS, the Director of Finance has indicated that funding is available for these services.

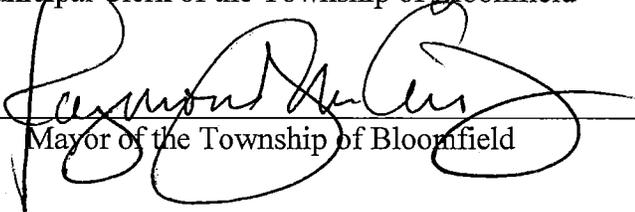
