2013 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT FOR PROPOSED TRAFFIC STRIPING & TRAFFIC CALMING ALONG BROUGHTON AVENUE

WHEREAS, the Township of Bloomfield requires the services of a firm to install traffic striping along Broughton Avenue as specified on a plan prepared by the Bloomfield Engineering Department, dated April 15, 2013; and

WHEREAS, the cost of this work is expected to exceed \$17,500.00; and

WHEREAS, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award the services of a firm having a contract with a Cooperative Pricing Council of which the township is a member without the need for a public bid; and

WHEREAS the Township of Bloomfield is a member of the Morris County Cooperative Pricing Council (MCCPC); and

WHEREAS, Denville Line Painting, Inc., 2 Green Pond Road, Rockaway, New Jersey have a contract with the MCCPC for traffic striping on roadways (Contract #36); and

WHEREAS, after a favorable review of the qualifications of the firm, the Township Engineer recommends that a contract be awarded to Denville Line Painting, Inc., 2 Green Pond Road, Rockaway, New Jersey for the unit prices provided under MCCPC contract #36 ; and

WHEREAS, the Director of Finance has indicated that funding is available in Township Account Number C-04-55-862-966.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for traffic striping
