2013 RESOLUTION POLICY

BLOOMFIELD SECTION EIGHT HOUSING CHOICE VOUCHER PROGRAM

WHEREAS, the Township of Bloomfield administers the Section Eight Housing Choice voucher program in conjunction with the U.S. Department of Housing and Urban Development; and

WHEREAS, the Section Eight Program includes written policies and procedures to assure that cases are processed uniformly and in accordance with all pertinent Federal, State, and local requirements; and

WHEREAS, the Mayor and Council of the Township of Bloomfield desire to amend the Policies and the Administrative Plan to help manage the fiscal obligations of the program in regard to people that move out of the Township's jurisdiction.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that policies and procedures for the operation of the Section Eight Housing Choice Voucher Program are amended to reflect that if a Bloomfield Housing Agency Section Eight Housing Choice Voucher tenant wishes to port to another jurisdiction, and the applicable payment standards of the proposed receiving agency/authority are higher than those of Bloomfield, the tenant will not be able to port to that jurisdiction unless the proposed agency/authority agrees to absorb the tenant;" and

BE IT, FURTHER RESOLVED, that the Director of Community Development is hereby authorized to operate the Section Eight Housing Choice Voucher Program in accordance with the revised "Policies and Procedures."
