**AWARD OF CONTRACT - RESURFACING OF JFK DRIVE NORTH AND SOUTH -
PHASE 1**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 15, 2013 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Resurfacing of JFK Drive North and South - Phase 1; and

WHEREAS, a total of five (5) bids were received and were referred to the Township Engineer for review; and

WHEREAS, the apparent low bidder was AJM Contractors, 300 Kuller Road, Clifton, NJ 07011; and

WHEREAS, after review of the bids, the Township Engineer hereby recommends that the contract be awarded to, AJM Contractors, 300 Kuller Road, Clifton, NJ 07011 in the amount of \$253,534.50; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's CDBG Roadway Program Account Numbers B-19-11-374-028 and B-19-12-389-028.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above project with AJM Contractors, 300 Kuller Road, Clifton, NJ 07011 in the amount of
