**2013 RESOLUTION AWARD OF CONTRACT**

**BUILDING CLEANING SERVICES FOR TOWNSHIP-OWNED BUILDINGS**

**WHEREAS**, sealed bids were received by the Purchasing Committee of the Township of Bloomfield for Cleaning Services for the Municipal Building, Law Enforcement Building and Central Communications on May 22, 2013 in the Council Chambers of the Municipal Building, Bloomfield, New Jersey; and

**WHEREAS**, all bids were referred to the Township Engineer; and

**WHEREAS**, the Township Engineer after due consideration to each of the bids submitted recommends that the contract be awarded Ocean Clean, 41 Sunset Terrace, Cedar Grove, New Jersey 07009 for the bid price of \$2,690.00 per month for a total annual price of \$32,280.00; and

**WHEREAS**, the base bid price includes floor waxing and carpet shampooing at no additional cost; and

**WHEREAS**, the Director of Finance has indicated that funding is available within the operating budget of the Engineering Department.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield that in accordance with the recommendation of the Township Engineer that the contract for the Cleaning Services for the Municipal Building, Law Enforcement Building and Central Communications is hereby awarded to Ocean Clean, 41 Sunset Terrace, Cedar Grove, New Jersey 07009 for the bid price of \$2,690.00 per month for a total annual price of \$32,280.00.
