2013 RESOLUTION REJECTION OF BIDS

**REJECTION OF BIDS FOR THE PULASKI PARK BASKETBALL COURT
RECONSTRUCTION**

WHEREAS after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 21, 2013 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Pulaski Park Basketball Court Reconstruction; and

WHEREAS, the bids received were referred to the Township Engineer for review; and

WHEREAS, a total of two (2) bids were submitted to the Township Engineer and the project consultant, Kinsey Associates for review and recommendation; and

WHEREAS, the contract prices for both bids were above the Engineer's Estimate and above the maximum amount of funding allocated for the project; and

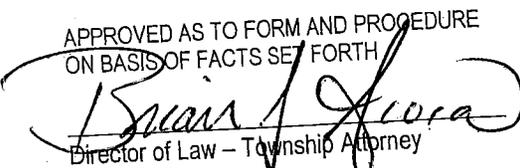
WHEREAS, the project consultant was also of the opinion that his estimate was fair and reasonable for the scope of work; and

WHEREAS, it was the further recommendation of the project consultant that both bids be rejected and the project re-bid in the hope of receiving more competitive bids from a larger field of bidders; and

WHEREAS, the Mayor and Council hereby accepts the recommendation of the Township Engineer and the project consultant to reject all bids and re-bid the project.

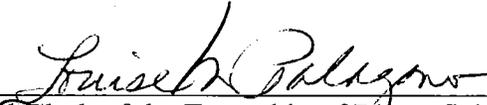

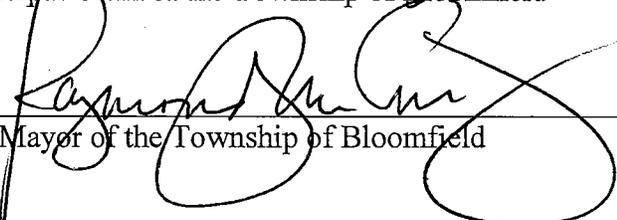
Park Basketball Court Reconstruction and authorize the Township Engineer to re-bid the project.
