2013 RESOLUTION APPROVAL

AUTHORIZING AN AGREEMENT WITH THE COUNTY OF ESSEX TO RESURFACE RIDGEWOOD AVENUE FROM WATCHUNG AVENUE TO BROOKDALE PARK

WHEREAS, Ridgewood Avenue, from Watchung Avenue to its dead end at Brookdale Park, is municipally owned and maintained by the Borough of Glen Ridge, the Township of Bloomfield and the Township of Montclair; and

WHEREAS, all three municipalities desire to have this portion of the roadway resurfaced; and

WHEREAS, the County of Essex will be undertaking the resurfacing of Ridgewood Avenue from Bloomfield Avenue to Watchung Avenue which is under their jurisdiction; and

WHEREAS, the County of Essex has agreed to resurface the portion of Ridgewood Avenue between Watchung Avenue and Brookdale Park if the Borough of Glen Ridge, the Township of Bloomfield and the Township of Montclair agree to each contribute one-third (1/3) of the cost to resurface this portion of the road; and

WHEREAS, the Township will issue payment to the County of Essex upon completion of the work and after review and approval of the as-build quantities by the Township Engineer; and

WHEREAS, all three municipalities are agreeable to this arrangement.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield formally approve of a one-third contribution to the cost of resurfacing Ridgewood Avenue from Watchung Avenue to Brookdale Park; and

BE IT FURTHER RESOLVED, that the Mayor of the Township of Bloomfield is

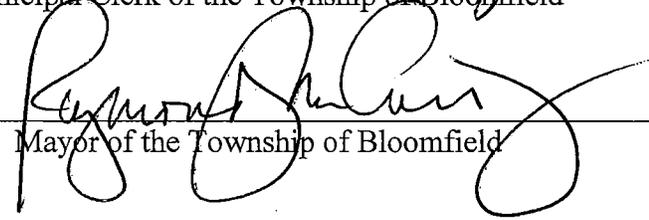
