2013 RESOLUTION CHANGE ORDERS

2010-2011 CAPITAL ROADWAY & TRAFFIC CALMING PROGRAM - CHANGE ORDER NO. 1

9-5

WHEREAS, the Township of Bloomfield entered into a contract for the 2010-2011 Capital Roadway & Traffic Calming Program with D.L.S. Contracting, Inc., 633 Franklin Avenue, Suite 170, Nutley, New Jersey 07110 (hereinafter "the Contractor"); and

WHEREAS, during the course of construction, additional striping was requested by the Township Engineer to improve traffic safety along Broughton Avenue; and

WHEREAS, the contractor provided a cost proposal to perform the additional striping at a cost of \$27,000.00; and

WHEREAS, the Township Engineer has reviewed cost associated with Change Order No. 1 and recommends the Change Order be approved; and

WHEREAS, Change Order No. 1 represents an increase in the cost of the contract in the amount of \$27,000.00 or 5.2%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Capital Account #C-04-55-850-965; #C-04-55-851-966 and. #C-04-55-862-966.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
