2013 RESOLUTION CHAPTER 159

9-7

AUTHORIZING THE INSERTION INTO THE 2013 MUNICIPAL BUDGET PURSUANT TO N.J.S.A. 40A:4-87 (CHAPTER 159, P.L. 1948) OF A SPECIAL ITEM OF REVENUE IN THE FORM OF A INTERLOCAL SERVICE AGREEMENT BLOOMFIELD BOARD OF EDUCATION HEALTH SERVICES NURSING.

WHEREAS, the Governing Body ("Governing Body") of the Township of Bloomfield finds and declares the N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services ("Director"), within the State of New Jersey Department of Community Affairs, may approve the insertion of any special item of revenue in the budget of any county or municipality; and

WHEREAS, the Governing Body further finds and declares that N.J.S.A. 40A:4-87 provides that the Director may also approve the insertion of any item an appropriation for an equal amount; and

WHEREAS, the Governing Body further finds and declares that it is the best interest of citizens of the Township to request approval of the insertion into the Township's 2013 Municipal Budget of an item of revenue based upon Interlocal Agreement secured by the Township from the Bloomfield Board of Education.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Township of Bloomfield does hereby request that the Director of the Division of Local Government Services, within the State of New Jersey Department of Community Affairs, approve the insertion into the Township's 2013 Municipal Budget of an item of revenue in the sum of \$8,056.00, which item is now available as revenue in the form of a Interlocal Services Agreement Bloomfield Board of Education Health Services - Nursing; and

Bloomfield Board of Education Health Services - Nursing


