**2013 RESOLUTION CHANGE ORDERS**

**FOLEY FIELD BLEACHER REPLACEMENT - CHANGE ORDER NO. 1-FINAL**

**WHEREAS**, the Township of Bloomfield entered into a contract for the Replacement of The Foley Field Bleachers with TecCon Contractors, Inc., 9 Dodd Street, East Orange, New Jersey 07017 (hereinafter "the Contractor") for a total contract amount of \$979,800.00; and

**WHEREAS**, the contract allowed for a contingency of \$127,800.00 to account for unforeseen conditions that might have arisen during the project; and

**WHEREAS**, upon completion of the project, the total amount of contingency approved for the project was \$28,000.00 thereby leaving a surplus of \$99,299.23 of unused contingency funding; and

**WHEREAS**, the Township Engineer hereby recommends that the contract price be reduced by \$99,299.23 to a new contract amount of \$880,500.77 under Change Order No. 1 - Final; and

**WHEREAS**, Change Order No. 1 - Final represents a 10.1% decrease in the cost of the contract; and

**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and


**WHEREAS**, this Change Order was found to be beneficial and necessary.

**NOW THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final, is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
