**AWARD OF CONTRACT FOR DISPOSAL OF VEGETATIVE WASTE**

**WHEREAS**, sealed bids were received by the Purchasing Committee of the Township of Bloomfield for hauling and disposal of vegetative waste, on July 17, 2013 in the Council Chambers of the Municipal Building, Bloomfield, New Jersey; and

Item 1 - Soft Vegetative Waste:	7,000 CY @ \$12.50 = \$ 87,500.00
Item 2 - Store a remove leaves At Grove Street:	5,000 CY @ \$12.50 = \$ 62,500.00
Item 3 - Store a remove leaves At Alternate Location:	5,000 CY @ \$13.50 = \$ 67,500.00


