**REJECTION OF BIDS FOR THE PULASKI PARK BASKETBALL COURT  
RECONSTRUCTION - RE-BID**

**WHEREAS** after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on July 2, 2013 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Pulaski Park Basketball Court Reconstruction - Re-Bid; and

**WHEREAS**, the bids received were referred to the Township Engineer for review; and

**WHEREAS**, a single bid was received and submitted to the Township Engineer and the project consultant, Kinsey Associates for review and recommendation; and

**WHEREAS**, the single bid was received from Halecon, Inc., 136 Billian Street, Bridgewater, NJ 08807, for a Base Bid amount of \$125,000.00; and


**WHEREAS**, the contract prices for this re-bid remain above the Engineer's Estimate and above the maximum amount of funding allocated for the project; and

**WHEREAS**, it was the recommendation of the project consultant and the Township Engineer that this bid be rejected and the project be re-bid under a revised scope of work; and

**WHEREAS**, the Mayor and Council hereby accepts the recommendation of the Township Engineer and the project consultant to reject all bids and re-bid the project under a revised scope of work.


