2013 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT FOR MODERNIZATION OF MAIN LIBRARY ELEVATOR

WHEREAS, the Township of Bloomfield requires the services of a firm to modernize the elevator in the Bloomfield Main Library which is currently inoperable and out of compliance with the applicable building codes; and

WHEREAS, the cost of this work is expected to exceed \$17,500.00; and

WHEREAS, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award the services of a firm having a New Jersey State Contract without the need for a public bid; and

WHEREAS, KONE, Inc., 150 Mt. Bethel Road, Warren, NJ 07059, currently holds State Contract #79016 for elevator replacement, repair and maintenance services; and

WHEREAS, after a favorable review of the qualifications of the firm, the Township Engineer recommends that a contract be awarded to KONE, Inc. 150 Mt. Bethel Road, Warren, NJ 07059, under State Contract #79016 for an amount not to exceed \$67,515.00; and

WHEREAS, the Director of Community Development has indicated that funding is available in the Township of Bloomfield Community Development Block Grant (CDBG) Program; and

WHEREAS, the Mayor and Council approved to hire KONE, Inc. to complete the work.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby reaffirms the resolution passed on August 19, 2013 to accept the recommendation of the Township Engineer and he may enter into a contract for modernization of the elevator in the Bloomfield Main Library to KONE, Inc., 150 Mt. Bethel Road, Warren, NJ 07059, under State Contract #79016 for an amount not to

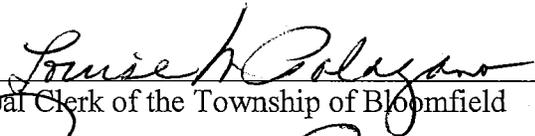

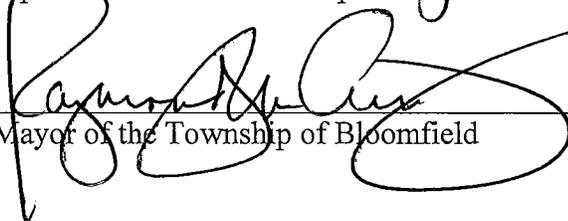
