2013 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT FOR DISPOSAL OF EXCAVATED MATERIAL FROM THE TOWNSHIP WATERMAIN CLEANING AND LINING PROGRAM

WHEREAS, the Township of Bloomfield requires the services of a firm to remove excavated material from a watermain cleaning project; and

WHEREAS, the cost of this work is expected to exceed \$17,500.00; and

WHEREAS, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award a contract to perform services to a firm having a contract with a Cooperative Pricing Council of which the Township is a member without the need for a public bid; and

WHEREAS the Township of Bloomfield is a member of the Morris County Cooperative Pricing Council (MCCPC); and


WHEREAS, DCRS, LLC, P.O. Box 328, Cream Ridge, NJ 08514 has a contract with the MCCPC for removal and disposal of regulated excavated material (Contract #49); and

WHEREAS, after a favorable review of the qualifications of the firm, the Township Engineer recommends that a contract be awarded to DCRS, LLC, P.O. Box 328, Cream Ridge, NJ 08514 at a cost of \$52,500.00 or \$35.00 per cubic yard of material; and

WHEREAS, the Director of Finance has indicated that funding is available in Township Account Number W-06-55-583-591.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the removal and


