2013 RESOLUTION HEALTH BENEFITS CONTRACT

NEW HIRE HEALTH CARE COVERAGE

WHEREAS, the Township of Bloomfield currently provides health care coverage to all employees and their dependents; and

WHEREAS, the cost of providing these benefits is extremely expensive to the Township and therefore to the taxpayers; and

WHEREAS, the Mayor and Council have determined it will lower the cost of hiring new employees and therefore, proved some tax relief to the taxpayers if the Township no longer provides these benefits to new employees.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that all employees hired after September 15, 2013 shall be entitled to health benefits coverage, however, the employees shall have to pay the Township's cost for any dependents that they want covered; and

BE IT FURTHER RESOLVED, that this policy shall not affect the employees requirement to pay 15% of the cost of their Health Benefits or any amount required by State of Federal law, whichever is higher; and

BE IT FURTHER RESOLVED, that if State or Federal Law requires the Township to provide coverage to the employee and any dependents (without allowing for the employee to pay for the cost of coverage for the dependent as required under this resolution,) the Township shall only be required to provide the basic minimum level of coverage as required by law to the employee and their dependents. In that case, any employee wanting additional coverage for the employee and their dependents will have to pay the Township the full amount of the cost

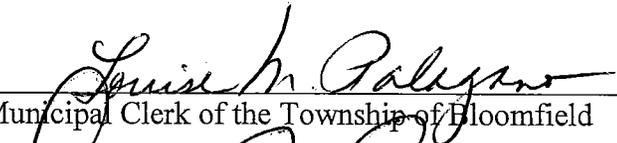

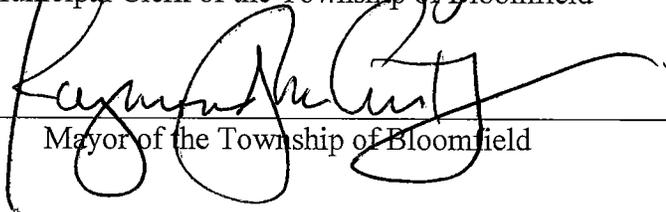
