**2013 RESOLUTION CHAPTER 159**

**PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE AND APPROPRIATION IN THE BUDGET CHAPTER 159/6**

---

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and


**WHEREAS**, said Director may also approve the insertion of any items of appropriation for equal amount; and

**WHEREAS**, after the 2013 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$125,738.00 from the Essex County Division of Training and Employment for Hurricane Sandy Disaster (NEG) - Account # 3-01-08-364-000.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council authorizes the Township Administrator to execute any documents necessary to receive the \$125,738.00 grant for Disaster Temporary Job NEG; and

**BE IT FURTHER RESOLVED**, that the Township of Bloomfield hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the Budget of the year 2013 in the sum of \$125,738.00 as an anticipated revenue from Essex County Division of Training and Employment - Account # 3-01-08-364-000.


