2013 RESOLUTION AGREEMENTS

FORM A JOINT HEALTH INSURANCE FUND

WHEREAS, by the appropriate mechanism and procedures by the duly constituted officials and or their designees herein below identified, and pursuant to the authority expressed at New Jersey Statutes Annotated, Section 40A:10-36, et seq. and specifically New Jersey Annotated Code, section 11:15-3.3, that the Township of Bloomfield, RESOLVES the following action:

1. To Agree to join together with other local units of government (to include a county, municipality, school district or any contracting unit as described in N.J.S.A. 40A:11-2 and N.J.A.C. 11:15-3.2) to establish a Joint Health Insurance Fund; and
2. Provided further, that this Resolution is conditioned upon the subsequent receipt, review and express approval by the Township of Bloomfield, of the subsequent terms of membership and By-laws as promulgated by such Joint Health Insurance Fund; and
3. Provided further, that such subsequent approval by the Township of Bloomfield of the terms of membership and By-laws be evidenced by a written agreement executed by a duly authorized official of the Township of Bloomfield, and such agreement shall include (but not be limited to) the following terms:
 - a. The extent of participation by the Township of Bloomfield in the contemplated Joint Health Insurance Fund is limited to the self funding of health benefits; and
 - b. The extent of membership in the Joint Health Insurance Fund shall be for an initial term of no more than three years , in compliance with N.J.S.A. 40A:11-15(6) and N.J.A.C. 11:15-3.10; and
 - c. That as a condition of participation in the contemplated Joint Health Insurance Fund, that each Fund member has never defaulted on claims if self-insured, and if not self-insured, have not been cancelled for non-payment of insurance premiums for a period of at least two years prior to application.
