2013 RESOLUTION APPOINTMENT

TEMPORARY STAFF

WHEREAS, the Township of Bloomfield's Department of Works needs to hire additional temporary staff members that will work until January 24, 2014; and

WHEREAS, the employees will be paid through the New Jersey Department of Labor and Workforce Development in accordance with the attached agreement; and

WHEREAS, Aggrey M. Gaime, Kelsey Gary, Hezekiah Hughes, Royal King, Demetrick Pittman, Anthony Santora, Enrique Torres and Michael A White recognize and understand that these temporary staff positions will end on January 24, 2014; and

WHEREAS, Aggrey M. Gaime, Kelsey Gary, Hezekiah Hughes, Royal King, Demetrick Pittman, Anthony Santora, Enrique Torres and Michael A White will work at the rate of \$14.00/per hour for 40 hours per week, and will not be entitled to work overtime, and will not receive health benefits as temporary staff employees; and

WHEREAS, the Director of Finance has indicated that funding is available for these positions subject to the conditions in the attached Department of Labor and Workforce Development Agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby hire the above reference employees as temporary staff employees starting September 16, 2013 and ending on January 24, 2014 subject to the conditions contained this resolution; and

BE IT FURTHER RESOLVED, that these temporary appointments will automatically terminate on January 24, 2014 without any further action by the Mayor and Council.



AMENDMENT TO CONTRACT
Hurricane Sandy Disaster Temporary Job NEG Agreement

AGREEMENT:

This agreement, made by and between the County of Essex, a body politic and corporate of the State of New Jersey, hereafter referred to as the "County" and the Township of Bloomfield, 230 Grove Street, Bloomfield, NJ 07003, hereafter referred to as the "Vendor" amends their agreement, approved by Resolution R-13-00080 of the Essex County Board of Chosen Freeholders on January 25, 2012.

NOW, THEREFORE, in consideration of the mutual promises, covenants and agreements herein contained, the parties hereto do hereby covenant and agree to amend the agreement as follows:

EFFECTIVE DATE OF CONTRACT:

The original contract term shall be extended for a period of nine (9) months, December 1, 2012 – January 29, 2014.

SERVICES TO BE PROVIDED:

The Township of Bloomfield shall continue to provide temporary employment on projects for the clean-up, demolition repair, renovation and reconstruction of destroyed public structures, facilities and lands within the affected communities under the same terms and conditions as the original contract and agreement.

COMPENSATION:

The total program cost shall remain unchanged, including \$ 90,854.00 for administrative costs.

ADDITIONAL CONDITIONS:

All other terms, conditions, certifications and representations contained in the original agreement shall remain in effect through date of this amendment.
