RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2012 TAX APPEAL ENTITLED JAYNE GIOVANNELLI/GILBERT PEREZ V. TOWNSHIP OF BLOOMFIELD, DOCKET NO.: 016398-2012 OF THE TAX ASSESSMENT OF BLOCK 991, LOT 111, KNOWN AS 9 SCOTT ROAD, IN THE TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NEW JERSEY


