RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2012 TAX APPEAL ENTITLED FARRAND STREET ASSOCIATES V. TOWNSHIP OF BLOOMFIELD, DOCKET NO.: 005750-2012 OF THE TAX ASSESSMENT OF BLOCK 225, LOT 15, KNOWN AS 50 FARRAND STREET, IN THE TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NEW JERSEY
