**2013 RESOLUTION TAX APPEALS**

**RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2012 TAX APPEAL ENTITLED ALFRED & NANISSA HARVEY V. TOWNSHIP OF BLOOMFIELD, DOCKET NO.: 014840-2012 OF THE TAX ASSESSMENT OF BLOCK 546, LOT 31, KNOWN AS 149 BELLEVILLE AVENUE, IN THE TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NEW JERSEY**
