WHEREAS, Victor DeFilippo recognizes that he will not receive health benefits and the maximum work week a maximum of 20 hours; and


WHEREAS, the Finance Director has certified that funds are available to make this part-time appointment.


BE IT FURTHER RESOLVED, Victor DeFilippo recognizes that the Township can terminate this position without any further action from the Mayor and Council.
