2013 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT - CONSTRUCTION OF BUTTERFLY DISCOVERY CENTER RECREATION FACILITY

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on August 13, 2013 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the construction of the Butterfly Discovery Center Recreation Facility; and

WHEREAS, a total of five (5) bids were received and were referred to the Township Engineer for review; and

WHEREAS, after review of the bids and upon recommendation by the project consultant, Terra Noble Design, P.A., the Township Engineer hereby recommends that the contract be awarded to the lowest responsible bidder, Let It Grow, Inc., 52 Ackerson Street, River Edge, N.J. 07661 for the Base Bid and Alternate A in the amount of \$559,661.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Township of Bloomfield Open Space Trust Fund.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above intersection improvements with Let It Grow, Inc., 52 Ackerson Street, River Edge, N.J. 07661 for the Base Bid and Alternate A in the amount of \$559,661.00.
