2013 RESOLUTION AWARD OF CONTRACT

RENOVATION OF BASKETBALL COURTS AT PULASKI PARK

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on October 23, 2013 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Renovation of Basketball Courts at Pulaski Park; and

WHEREAS, a total of two (2) bids were received and were referred to the Township Engineer for review; and

WHEREAS, the apparent low bidder was DiMilia, Inc., P.O. Box 3366, Memorial Station, Upper Montclair, NJ 07043 for a base bid of \$98,250.00, Alternate A1 in the amount of \$9,600.00, Alternate 1B in the amount of \$4,500.00 and Alternate 1C in the amount of \$4,000.00; and

WHEREAS, after review of the bid, the Township Engineer hereby recommends that the contract be awarded to, DiMilia, Inc., P.O. Box 3366, Memorial Station, Upper Montclair, NJ 07043 for a base bid of \$98,250.00, Alternate A1 in the amount of \$9,600.00, Alternate 1B in the amount of \$4,500.00 and Alternate 1C in the amount of \$4,000.00 for a total contract amount of \$116,350.00; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Roadway Program Account Numbers C-04-55-867-975 and C-04-55-864-947.


