2013 RESOLUTION CHAPTER 159

PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE AND APPROPRIATION IN THE BUDGET CHAPTER 159/14

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any items of appropriation for equal amount; and

WHEREAS, after the 2013 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$18,034.00 from the Essex County Division of Community Action For Social Services for Homeless # 3-01-08-359-000.

NOW, THEREFORE, BE IT RESOLVED, contingent upon passage of said grant from the County of Essex the Township of Bloomfield hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the Budget of the year 2013 in the sum of \$18,034.00 as an anticipated revenue from the Essex County Division of Community Action for Social Services for Homeless - Account # 3-01-08-359-000.

BE IT FURTHER RESOLVED, contingent upon passage of said grant from the County of Essex that a like sum of \$18,034.00.00 be and the same is hereby appropriated under the Budget of the Township of Bloomfield SSH Grant - Account #3-01-40-359-028; and


BE IT FURTHER RESOLVED, that two (2) certified copies of this resolution be filed with the Director of the Division of Local Government Services, Department of Community Affairs.
