**2013 RESOLUTION APPOINTMENT**

**REVISED PART-TIME TEMPORARY CONSTRUCTION CODE OFFICIAL**

**WHEREAS**, on Monday, December 2, 2013, the Mayor and Council passed a resolution appointing Victor DeFilippo as part-time temporary construction code official; and

**WHEREAS**, the resolution had incorrect language and the resolution should read as follows; and

**WHEREAS**, a vacancy exists in the Township of Bloomfield Inspections Department for the position of part-time temporary construction code official; and

**WHEREAS**, the Director of Community Development and Inspections recommends hiring Victor DeFilippo to the position of part-time temporary construction code official; and

**WHEREAS**, Victor DeFilippo recognizes that he will not receive health benefits and the work week is a minimum 20 working hours and a maximum of 25 working hours; and

**WHEREAS**, the Finance Director has certified that funds are available to make this part-time appointment.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Victor DeFilippo is hereby appointed to the position of part-time temporary construction code official at a rate of \$45.00 per hour effective immediately subject to the terms of this resolution; and

**BE IT FURTHER RESOLVED**, that Mr. DeFilippo's employment with the Township will automatically on terminate January 15, 2014, without further action by the Council.
