WHEREAS, Victor DeFilippo, recognizes that the appoint is provisional and temporary and even if he complies with all the requirements to become permanently appointed to the position of Code Enforcement Officer the Mayor and Council may not permanently fill the position and as a temporary provisional appointment the Mayor and Council can remove him from this position at any time; and

WHEREAS, the Finance Director has certified that funds are available to make this temporary provisional appointment.
