2012 RESOLUTION CHANGE ORDERS

**CONTRACT AMENDMENT FOR ADDITIONAL
CONSTRUCTION ADMINISTRATION SERVICES FOR UPPER
MEMORIAL PARK**

WHEREAS, the Township of Bloomfield currently has a contract with Birdsall Services Group, 611 Industrial Way West, Eatontown, New Jersey 07724 (the Consultant) for the preparation of design and construction administration services for the improvements to Upper Memorial Park; and

WHEREAS, during the design process, it was determined that approval of a Remedial Action Workplan (RAW) was required to address the removal of historic fill discovered on the site in accordance to N.J.D.E.P. and Green Acres requirements; and

WHEREAS, the RAW required modification to the original design as well as additional construction administration services to address appropriate removal and disposal of historic fill in accordance with the RAW; and

WHEREAS, during the course of construction, additional remediation services were required to monitor the removal and disposal of additional historic fill which was unforeseen in the original proposal; and

WHEREAS, Birdsall Services Group has provided an amendment to their proposal to provide the required services in the amount of \$6,500.00; and

WHEREAS, it is the recommendation of the Township Engineer to amend the current contract in the amount of \$6,500.00 for a new contract price of \$73,050.00 to allow for the additional remediation oversight; and

WHEREAS, funding for the amendment is available in the Township's capital account
