2012 RESOLUTION AWARD OF CONTRACT

BUILDING CLEANING SERVICES FOR TOWNSHIP-OWNED BUILDINGS

WHEREAS, sealed bids were received by the Purchasing Committee of the Township of Bloomfield for Cleaning Services for the Municipal Building, Law Enforcement Building, Central Communications and the Civic Center as an alternate bid, on January 31, 2012 in the Council Chambers of the Municipal Building, Bloomfield, New Jersey; and

WHEREAS, all bids were referred to the Township Engineer; and

WHEREAS, the Township Engineer after due consideration to each of the bids submitted recommends that the contract be awarded to the lowest responsible bidder Maverick Building Services, 22 Chestnut Street, Rutherford, New Jersey 07070 for the base bid price of \$2,656.00 per month for a total annual price of \$31,872.00; and

WHEREAS, the base bid price includes floor waxing and carpet shampooing at no additional cost; and

WHEREAS, the Director of Finance has indicated that funding is available within the operating budget of the Engineering Department.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that in accordance with the recommendation of the Township Engineer that the contract for the Cleaning Services for the Municipal Building, Law Enforcement Building and Central Communications is hereby awarded to Maverick Building Services, 22 Chestnut Street, Rutherford, New Jersey 07070.


