2012 RESOLUTION DUPLICATE TAX SALE

ISSUANCE OF DUPLICATE TAX SALE CERTIFICATES

WHEREAS, P.L. 1997, Chapter 520, requires the authorization of the governing body for replacement and issuance of a duplicate tax sale certificate held by a third-party lien holder which has been destroyed or lost; and

WHEREAS, Bonita West LLC has indicated that he was provided with tax sale certificates which have been either lost or destroyed.

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby authorize the Tax Collector, upon receipt of an appropriate affidavit from the owner of the certificate, to prepare a replacement certificate for the following tax sale certificates for Tax Sale Certificate #11-00016, 11-00024, 11-00079, 11-00109, 11-00122, 11-00205, 11-00209, 11-00223 and issue to the original lien holder known as Bonita West LLC, 8 Spruce Hill Court, Pleasantville, NY 10570; and

BE IT FURTHER RESOLVED, that these replacement certificate, duplicated in original form, shall be marked as "duplicate", and a \$25 fee shall be assessed to the above mentioned lien holder for the preparation of each said duplicate certificate.

BE IT FURTHER RESOLVED, that a copy of said duplicate certificates shall be attached herewith, and a certified copy be forwarded to the Tax Collector and lien holder.


