**2012 RESOLUTION AUTHORIZATIONS**

**HOLD HARMLESS AGREEMENT WITH ESSEX COUNTY FOR  
INSTALLTION OF PEDESTRIAN CROSSWALKS AND  
SIGNAGE.**

WHEREAS, it is the desire of the Mayor and Council of the Township of Bloomfield to install pedestrian crosswalks and signage at the following locations within the Essex County right-of way based upon the recommendations of the Township Traffic Division and Township Engineer:

-Broad Street at Vernon Terrace.

-Broad Street at Osborne Street

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby requests permission from the County of Essex to install pedestrian stanchion signs and pavement striping for crosswalks at the above locations; and

BE IT FURTHER RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that the Township of Bloomfield will accept the responsibility for installation and maintenance of the pedestrian stanchions and crosswalks and will hold Essex County harmless from any claims and litigation from any types of incidences related to the signs installed within the County right-of-way. The signage and striping will be installed in accordance with the guidelines issued by the Commissioner of Transportation.



WHEREAS, the Township’s Resolution insofar as it affects a County road, has been approved by the Office of the County Engineer; and


WHEREAS, the Township’s Ordinance does not conflict with any County regulations; and
