**2012 RESOLUTION APPOINTMENT**

**FIREFIGHTER**

**WHEREAS**, a vacancy exists in the Bloomfield Fire Department in the position of Firefighter;  
and

**WHEREAS**, the Department of Civil Service Commission of the State of New Jersey has promulgated a list of eligible candidates, who have qualified by competitive examination, for appointment to the position of Firefighter in the Bloomfield Fire Department; and

**WHEREAS**, Brian Shaw appears on the list of eligible candidates; and


**WHEREAS**, the Finance Director has certified that funding is available to hire this candidate;  
and

**WHEREAS**, the Fire Chief recommends that Brian Shaw be appointed to the position of Firefighter, effective April 17, 2012.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Brian Shaw be and is hereby appointed Firefighter in the Fire Department of the Township of Bloomfield effective April 17, 2012 at the 1<sup>st</sup> step of salary in effect as reflected in the Union Agreement, subject to certification by the Civil Service Commission, residency verification, successful medical review and criminal background check.


