

**2012 RESOLUTION CHANGE ORDERS**

**2011 Sidewalk Repair Program - Change Order #1 - Final**

**WHEREAS**, the Township of Bloomfield entered into a contract for the 2011 Sidewalk Repair Program with Diamond Construction, 35 Beaverson Boulevard, Suite 12C, Brick, New Jersey 08723 (hereinafter "the Contractor"); and

**WHEREAS**, during the course of construction, unforeseen, site conditions were encountered, which required modifications to the scope of work; and

**WHEREAS**, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

**WHEREAS**, Change Order No. 1 - Final represents a decrease in the cost of the contract in the amount of \$10,838.20; and

**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and

**WHEREAS**, this Change Order was found to be beneficial and necessary.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final, is hereby approved and the Chief Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
