## 2012 RESOLUTION AWARD OF CONTRACT

### Award of Bid For Foley Field Bleacher Replacement

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 1, 2012 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Foley Field Bleacher Replacement; and

**WHEREAS**, the bids received were referred to the Township Engineer for review; and

**WHEREAS**, a total of three (3) bids were submitted to the Township Engineer for review and recommendation; and

**WHEREAS**, after review of the bids, the lowest bidder was Tec-Con Contractors, Inc., 9 Dodd Street, East Orange New Jersey 07017 for the base bid in the amount of \$979,800.00; and


**WHEREAS**, the bid documents submitted by Tec-Con Contractors, Inc. were determined to be complete by the Township Engineer; and

**WHEREAS**, it is the recommendation of the Township Engineer that the contract be awarded to Tec-Con Contractors, Inc., 9 Dodd Street, East Orange New Jersey 07017 for the base bid in the amount of \$979,800.00; and

**WHEREAS**, the Director of Finance has certified that funding is available for this project through a Green Acres Grant, Project Number 0702-10-007 and Township Capital Account # C-04-55-923-947.


