**2012 RESOLUTION LEAVE OF ABSCENCE**

**FAMILY MEDICAL LEAVE OF ABSENCE**

**WHEREAS**, written application has been filed by Employee # 01433, for a family and medical leave of absence without pay, for personal reasons; and

**WHEREAS**, Employee # 01433 has exhausted all she earned sick leave with the Township of Bloomfield.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Employee # 01433 is hereby granted a leave of absence with pay, from her position for a period of ninety (90) days effective April 24, 2012, provided, however, that the leave is conditioned upon the following:

1. During said leave of absence, Employee # 01433 will not accrue sick leave, vacation leave, personal leave, holiday time coming, holiday pay and uniform allowance, in accordance with the terms and conditions of the Collective Bargaining Agreement that controls the employees employment.
2. During said leave of absence, employee shall continue to be covered for pension, health benefits, dental plan and prescription drug plan and life insurance in accordance with the terms and conditions of the agreement identified in paragraph 1 above.
3. During said leave of absence, if employee engages in any other gainful employment, her leave with the Township shall be automatically terminated.
4. Prior to her return to work the employee must submit a note from her Physician, who must certify to the employee's fitness to return to work.
