



2012 RESOLUTION APPROVAL

PART-TIME LABORER'S

WHEREAS, the Township of Bloomfield's Department of Works needs to hire part-time temporary staff members that will work until August 31, 2012; and

WHEREAS, Michael Rodriguez, Andrew Coco, and Anthony Giaimo, recognized and understand that their employment with the Township will end on August 31, 2012 because their position is a temporary part-time position; and

WHEREAS, Michael Rodriguez, Andrew Coco, and Anthony Giaimo, will not work longer than 24 hours per week at the rate of \$10.50/per hour and will not receive health benefits as temporary part-time employees; and

WHEREAS, the Director of Finance has indicated that funding is available for these positions.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby hires Michael Rodriguez, Andrew Coco, and Anthony Giaimo, as part-time temporary employees beginning June 25, 2012 and ending on August 31, 2012 subject to the conditions contained this resolution; and

BE IT FURTHER RESOLVED, that these temporary appointments will automatically terminate on August 31, 2012 without any further action by the Mayor and Council


