**WHEREAS**, the Township of Bloomfield's Department of Public Works needs to hire part-time temporary staff members; and

**WHEREAS**, Miguel Tirado, has indicated a desire to be appointed as a temporary part-time staff member; and

**WHEREAS**, the Director of Public Works recommends that Miguel Tirado be appointed a temporary part-time staff member; and

**WHEREAS**, Miguel Tirado, recognizes and understands that his employment with the Township will end on August 31, 2012 because the position is a temporary part-time position; and



**WHEREAS**, the Director of Finance has indicated that funding is available for this position.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby hires Miguel Tirado, as part-time temporary employee beginning June 27, 2012 and ending on August 31, 2012 subject to the conditions contained this resolution; and

**BE IT FURTHER RESOLVED**, that Miguel Tirado temporary employment with the Township will automatically terminate on August 31, 2012 without any further action by the Mayor and Council


