

**2012 RESOLUTION AWARD OF CONTRACT**

**MONTGOMERY STREET & JFK DRIVE INTERSECTION IMPROVEMENTS**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 30, 2012 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Montgomery Street & JFK Drive Intersection Improvements; and

**WHEREAS**, a total of four (4) bids were received and were referred to the Township Engineer for review; and

**WHEREAS**, after review of the bids and upon recommendation by the project consultant, CME Associates., the Township Engineer hereby recommends that the contract be awarded to the lowest responsible bidder, Fai-Gon Electric, Inc., 140 Eleventh Street, Piscataway, NJ 08854 for a total contract cost of \$451,693.90; and

**WHEREAS**, the Director of Finance has indicated that funding is available within Township Account #2-01-40-302-154, which is reimbursable through a grant from the New Jersey Department of Transportation Trust Fund, and within Township Capital Account No. C-04-55-850-965; and


**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above intersection improvements with Fai-Gon Electric, Inc., 140 Eleventh Street, Piscataway, NJ 08854 for a total contract cost of \$451,693.90.
