2012 RESOLUTION - AWARD OF CONTRACT - BUKOWSKI PLACE AND JOHNSON AVENUE SANITARY SEWER REPLACEMENT

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on July 3, 2012 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Bukowski Place and Johnson Avenue Sanitary Sewer Replacement.

WHEREAS, a total of four (4) bids were received and were referred to the Township Engineer for review; and

WHEREAS, after review of the bids and upon recommendation by the project consultant, The Alaimo Group, the Township Engineer hereby recommends that the contract be awarded to the lowest responsible bidder, Shauger Property Services, Inc., 429 Dodd Street, East Orange, New Jersey 07017 in the amount of \$130,815.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Township Capital Account No. C-04-55-853-987; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above intersection improvements with Shauger Property Services, Inc., 429 Dodd Street, East Orange, New Jersey 07017 in the amount of \$130,815.00.
