

**2012 RESOLUTION ABC RENEWAL**

**SETTLEMENT AGREEMENT - HEARTBEAKERS**

**WHEREAS**, on or about July 30, 2012, Jamdan Associates, LLC t/a HeartBreakers, holder of Plenary Retail Consumption License No: 0702-33-007-006 (hereinafter "License") was served with a Notice of Charges alleging certain violations of the laws, rules and regulations governing the License; and

**WHEREAS**, on Monday, August 20, 2012, an administrative hearing was held at a regularly scheduled Township of Bloomfield Council meeting regarding the allegations in the Notice of Charges; and



**WHEREAS**, HeartBreakers has indicated that it has added infrared cameras to monitor the front of their building and in the future if any such incident occurs said incident will be taped by the cameras and therefore Bloomfield Police will be able to determine exactly what transpired.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby directs the Township Clerk to make it a condition of Jamdan Associates, LLC t/a HeartBreakers, Plenary Retail


