**2012 RESOLUTION AWARD OF CONTRACT**

**BLOOMFIELD CHILDREN'S LIBRARY HEATING SYSTEM UPGRADE**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on August 14, 2012 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Bloomfield Children's Library Heating System Upgrade; and

**WHEREAS**, a total of three (3) bids were received and were referred to the Township Engineer for review; and

**WHEREAS**, after review of the bids and upon recommendation by the project consultant, Maser Consulting, P.A., the Township Engineer hereby recommends that the contract be awarded to the lowest responsible bidder, C. Dougherty and Company, 7 Washington Avenue, Paterson, New Jersey 07503 in the amount of \$350,750.00; and

**WHEREAS**, the Director of Finance has indicated that funding is available within Township Capital Account #C-04-55-852-947.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above work with C. Dougherty and Company, 7 Washington Avenue, Paterson, New Jersey 07503 in the amount of \$350,750.00.


