**2012 RESOLUTION FOR REPAIR OF TRAFFIC SIGNAL BOX AND CONTROLLER AT BROUGHTON AVENUE AND CHAPEL STREET**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on August 14, 2012 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the repair of the traffic signal box and controller at Broughton Avenue and Chapel Street; and

WHEREAS, a single bid was received and was referred to the Township Engineer for review; and

WHEREAS, after review of the bid the Township Engineer hereby recommends that the contract be awarded to the Kevco Electric, Inc., 62-84 Arlington Avenue, Bloomfield, NJ 07003 for a total contract cost of \$29,575.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Township Account #C-04-55-850-965; and

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above reference work with Kevco Electric, Inc., 62-84 Arlington Avenue, Bloomfield, NJ 07003 for a total contract cost of \$29,575.00.
