**2012 RESOLUTION AGREEMENTS**

**MOON PALACE – DISCIPLINARY SETTLEMENT**

**WHEREAS**, the Township Council scheduled a hearing for the establishment referred to as Moon Palace on Monday, September 24, 2012, based upon alleged violations of liquor license rules and regulations; and

**WHEREAS**, in lieu of having a hearing Moon Palace has agreed that they would be required to have to police security on Friday and Saturday nights present outside the bar and that this requirement would be placed as a permanent condition on their liquor license; and

**WHEREAS**, Moon Palace also agreed that they would accept a 30 day suspension of their license and that the suspension would be held in abeyance for a period of one year; and

**WHEREAS**, if Moon Palace is found guilty of any additional charges within the one year time frame, the said thirty (30) day suspension will be implemented and served by Moon Palace, plus any additional suspension, fines or penalties imposed for the additional violation(s); and

**WHEREAS**, if Moon Palace’s operating record remains clean and is not found guilty of any additional charges within the one year period from the date of this Resolution the thirty (30) day suspension shall not be served.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby directs the Clerk to place a permanent condition on the liquor license of Moon Palace license 0702-33-020-005 that they be required to have police security outside the bar on Friday and Saturday nights; and


**BE IT FURTHER RESOLVED**, the condition to have police security on Friday and Saturday nights is a permanent condition of the license and can only be removed by further Council action; and

**BE IT FURTHER RESOLVED**, that a thirty day suspension of Moon Palace's liquor license is hereby imposed and shall be held in abeyance for a one year period in accordance with this resolution.
