2012 RESOLUTION LEASE/PURCHASE AGREEMENTS

Police Patrol Vehicle Purchase Request For 6 Patrol Cars and 1 SUV

WHEREAS, the Chief of Police has requested that the Township purchase a total of seven police vehicles, one Ford Police Interceptor SUV, and six Marked Ford Police Interceptor Sedans for the Bloomfield Police Department; and


WHEREAS, the above described vehicles can be purchased under the Morris County CO-OP Contract #15A item's 2 & 1 from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07962; and

WHEREAS, Beyer Ford Fleet Leasing, has submitted a proposal to sell the Ford Police Interceptor SUV at a cost of \$37,451.75 and the six Ford Police Interceptor Sedans for the Bloomfield Police Department at a cost of \$37,571.00 per vehicle which can be paid for by making three annual payments of \$52,342.00 and one payment from Capital Budget of \$68,400.00; and

WHEREAS, the Director of Finance has certified funds are available in the Operating budget.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor is authorized to sign and the Clerk to attest an agreement to purchase the six 2013 Ford Police Interceptor Sedans and the Ford Police Interceptor SUV from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07962 at a total cost of \$262,877.75.
