2012 RESOLUTION AWARD OF CONTRACT

GUIDE RAIL REPLACEMENT ALONG JOHN F. KENNEDY DRIVE

WHEREAS, in accordance with an agreement with the New Jersey Highway Authority, the Township of Bloomfield is responsible for the maintenance and repair of guide rail along John F. Kennedy Drive, south of Bloomfield Avenue; and

WHEREAS, based upon a notice from the New Jersey Turnpike Authority, who now operate the Garden State Parkway, the guide rail along JFK Drive northbound requires replacement and represents a traffic safety hazard; and

WHEREAS, the township of Bloomfield is a member of the Morris County Cooperative Purchasing Council (MCCPC); and

WHEREAS, M.L. Ruberton, 1512 Mays Landing Road, Folsom, NJ 08037 has a contract with MCCPC for the installation of steel guide rail and provided a price to replace the guide rail in an amount not to exceed \$43,075.00 ; and

WHEREAS, in accordance to the Local Public Contract Law, N.J.A.C. 5:34-7, products and services can be purchased through a cooperative purchasing council without the need for public bid or advertising by a member of the cooperative; and

WHEREAS, it is the recommendation of the Township Engineer that the guide rail be purchased and installed by M.L. Ruberton for an amount not to exceed \$43,075.00 in order to expedite the work and eliminate a potential traffic safety hazard.; and

WHEREAS, the Director of Finance has indicated that funding is available in Capital Account #C-04-55-850-965.




