2012 RESOLUTION CHANGE ORDERS

MILBANK PARK PLAY AREA IMPROVEMENTS CHANGE ORDER NO. 1

WHEREAS, the Township of Bloomfield entered into a contract for the Milbank Park Play Area Improvements with Rich Picerno Builders, LLC, 500 Hoiles Drive, Kenilworth, NJ 07033 for a contract price of \$39,055.00; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen subsurface site conditions and safety issues; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 and recommends the Change Order be approved; and

WHEREAS, Change order No. 1 represents an increase in the cost of the contract in the amount of \$2,500.00 or 6.4 percent and

WHEREAS, the Mayor and Council, based upon the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Community Development Block Grant Account #B-19-11-380-028.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
