2012 RESOLUTION ABC RENEWAL

AUTHORIZING RENEWAL OF INACTIVE PLENARY RETAIL CONSUMPTION LICENSE 0702-33-046-008

WHEREAS, application has been made to the Township of Bloomfield for a plenary retail consumption license renewal for DiSerio Inc in a timely manner, for the years 2011 - 2012 and 2012 - 2013; and

WHEREAS, the license has been duly located at 455 Broad Street in Bloomfield and has been inactive and the license holder has submitted a verified petition to the State of New Jersey Department of Public Safety, Division of Alcoholic Beverage Control for a Special Ruling under N.J.S.A. 33:1-12.39; and

WHEREAS, the Township has received a copy of the Special Ruling granted by the Director of the Division of Alcoholic Beverage Control permitting the license be reviewed by the Township for renewal, for the period of 2011-2012 and 2012-2013.

NOW, THEREFORE, BE IT RESOLVED, that a plenary retail consumption license be granted to DiSerio Inc., License # 0702-33-046-008 as an inactive license for the years 2011 - 2012 and 2012 - 2013; and
