WHEREAS, the Council would like to appoint Ted M. Ehrenburg as Township Administrator.

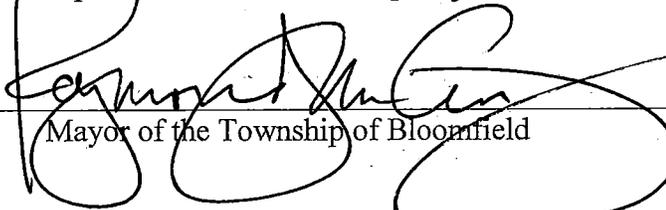
